- Should be a citizen of Sri Lanka.
- Age as indicated under the scholarship scheme.
- Applicants should have passed the G. C. E. (A/L) examination with relevant subjects related to the fields applicant intends to apply.
- Applicants should possess a high proficiency in English.

Applicants should be in good health.

Applicants those who apply for China and Japan Scholarships are required to sit for competitive examinations, which are conducted by the relevant Embassies in Sri Lanka. These examinations will be held in Colombo and the issuing of admission cards relating to the examinations will be done by the officers of the embassies of China and Japan in Sri Lanka.

01. China

Those candidates who apply for Physics, Engineering, Agriculture and Medicine are required to sit the standard examination in Mathematics, Physics and Chemistry. Those intending to study Economics Trade and Management are required to take up the examination in Mathematics. The examinations will be conducted in English Medium only. Applicants who apply for Arts subjects need not take up this examination.
